










# **Commonly used function**

# Power on/off

In the off mode, hold down the video/audio recording key to start, and enter the corresponding working state, hold down the video recording key to shut down.

# Audio recording

In the off mode, hold down the audio recording key for  $4\sim5$  seconds to start this unit and the green LED flashes. After releasing the key, wait for about  $8\sim9$  seconds; the audio recording will begin when a beep sound is heard, and the green LED stays on. During audio recording, press the audio recording key to save the recorded audio. Hold down the video recording key when the green LED flashes to shut down this unit.

# Video recording

In the off mode, hold down the video recording key for 4~5 seconds to start this unit and the green LED flashes. After releasing the key, wait about 8~9 seconds, the video recording will begin when a beep sound is heard and the LED changes to red and stays on. During video recording, press the video recording key to stop and save the recorded video. The LED will flash green (standby). To record a new file, quickly press the video record key, and the recording will start in 2 seconds. Hold down the video recording key when the green LED flashes to shut down the camera.

# Wi-Fi connection

- 1. In the off mode, hold down the audio recording key for about 14 seconds until the LED flashes green and then alternating green and red. Wi-Fi is enabled, and you can open the mobile app for connection and use; if no mobile phone is connected in 3 minutes, Wi-Fi will be shut down, and then this unit will be shut down automatically After a successful connection, the green indicator will flash, and this unit will enter standby mode.
- 2. In the standby mode, hold down the audio recording key for 6 seconds until the LED flashes alternately green and red. Wi-Fi is enabled, and you can open the mobile app for connection and use. If no mobile phone is connected in 3 minutes, Wi-Fi will be shut down, and then this unit will be shut down automatically; after a successful connection, the green indicator will flash, and this unit will enter the standby mode.

# Charging

Use a USB data cable to connect this unit to the PC or 5v USB port.

In the off mode, the LED will illuminate blue normally during charging and will go out when the unit is fully charged.

In the on mode, the blue indicator is normally on during charging, and the original indication will be maintained.

### Indicator status

Standby: The green indicator flashes.

Audio recording: The indicator shows a solid green light.

Video recording: The indicator shows a solid red light.

**Charging:** The indicator is blue (the green indicator flashes for several minutes) and will go out when this unit is fully charged.

**Low Battery:** The indicator rapidly flashes red, and then the unit shuts down **Memory Full:** The indicator flashes red and green alternately, and the camera

will make a "beep" "beep" sound

### PC Connection

As a storage device, this product can be connected to the PC using a USB data



When this unit is connected to the PC, the blue indicator is normally on.

• When moving a file into or from this product, please do not disconnect this product from the PC, or the file may be damaged.

• Android mobile phones can scan this QR code to download and set up the app. For all authority checking popups during setup, please click "Yes", otherwise the app will be unusable. For some mobile phones, the "mobile network" should be shut down for connection and use.

### Connection and Use

### Step 1:

Open Wi-Fi on this unit, and enable Wi-Fi using Method 1 or 2 in the "Wi-Fi Connection" instructions.

### Step 2:

Open the downloaded mobile app, and click on "Start Connection" on the mobile app screen, then the prompt "Make sure mobile Wi-Fi has been connected" will pop up; click on "Enter" to go to the Wi-Fi connection list, connect the **TC-100**xxxxx network manually, and enter the password "88888888"; after a successful connection, this unit will beep, and the app will enter the preview screen automatically.

### Audio recording

The app settings include: 1) video recording resolution; 2) loop overwriting; 3) pixel setup; 4) policeman ID setup; 5) device ID setup; 6) time setup; 7) formatting; and 8) factory reset.

- Audio recording via the app: Connect to the app, select "Audio Recording" on the main screen, and then press the "Audio Recording" icon to begin recording; press the "Audio Recording" icon again to save the recorded audio. (During audio recording, the screen is in the preview mode.)
- Photo taking via the app: Connect to the app, select "Photo Taking" on the main screen, and click on the "Photo Taking" icon of the app for photo taking.
- Video recording via the app: Connect to the app, select "Video Recording" on the main screen, and then press the "Video Recording" icon to begin recording; press the "Video Recording" icon again to save the recorded video.
- File download via the app: When the mobile app is connected to this unit, the app can download video, audio and photo files in this unit to the mobile phone. Select the file to be downloaded, and click the "Download" icon of the app. After the download completes, "Download Successful" will be displayed.

# 18 Warranty

This warranty against defects is given by Tooo Air Pty Ltd ABN 58 615 252 536

- 1. Consumer guarantees
- 1.1 Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

- 2. Warranty against defects
- 2.1 This warranty is in addition to and does not limit, exclude or restrict your rights under the Competition and Consumer Act 2010 (Australia) or any other mandatory protection laws that may apply.
- 2.2 We warrant our goods to be free from defects in materials and workmanship for the warranty period of 12 months from the date of original sale. Subject to our obligations under clause 1.2, we will at our option, either repair or replace goods which we are satisfied are defective. We warrant any replacement parts for the remainder of the period of warranty for the goods into which they are incorporated.

# Product type warranty

- 2.3 To the extent permitted by law, our sole liability for breach of a condition, warranty or other obligation implied by law is limited
- (a) in the case of goods we supply, to any one of the following as we decide -
- (i) the replacement of the goods or the supply of equivalent goods;
- (ii) the repair of the goods;
- (iii) the cost of repairing the goods or of acquiring equivalent goods;
- (b) in the case of services we supply, to any one of the following as we decide –
- (i) the supplying of the services again;
- (ii) the cost of having the services supplied again.
